Conditions of Entry:

1. The trials are run under the rules and regulations for the conduct of spaniel natural game trials, as approved by the NZ Gundog Trial Association (NZGTA). A copy of the regulations will be available at the trial from the Trials Secretary.
2. All dogs entered in the trial must be purebred spaniels and registered on the NZKC No.1 Register.
3. All competitors must be a financial member of a NZGTA affiliated club as well as a member of the NZGTA.
4. The Trial Captain reserves the right to make any adjustment to the schedule to meet any unexpected changes regarding trial grounds or judges.
5. All dogs on the trial host's property **must** have
 - A current dosing certificate for sheep measles.
 - Current Vaccination Record

Copies of these must be forwarded to the WSC Secretary workingspanielclub@gmail.com by **06 August**. These have to be supplied to the host property manager one week prior to the trial. These will not be accepted for sighting on the day of the trial.

6. All competitors and dogs compete at their own risk.
7. All competitors and spectators **MUST** wear a high visibility (blaze orange or fluorescent yellow) cap and vest.
8. Engraving of trophies to be the responsibility & cost of the winner.
9. This event will be a maximum of 18 dogs. If entries exceed 18 dogs, the club will hold a ballot at Midpoint Café, 102c Hobsonville Road, Hobsonville, on Sunday 19 July at 1000hrs. The draw for order of running will be made immediately after the ballot.
10. Any dog who misses out on the ballot will receive a refund of their entry fees.
11. All guns and competitors **MUST** be in possession of a 2026 Game Licence.
